**Fazila Bhimji** received her PhD from the University of California, Los Angeles, in Applied Linguistics and worked for several years as a senior lecturer at the University of Central Lancashire in the UK. She currently resides in Berlin and works as a part-time lecturer (Dozent) in the Department of Social Work at Evangelische Hochschule, Berlin. Her research interests include migration, diaspora, self-organised and grassroots activism, migration and future building, migration and advocacy work, racism and migration, coloniality, climate change and displacement. She is the author of several publications and two monographs as well as a podcast production on these topics. **Raika Khorshidian** (Georg Forster Postdoctoral Fellow at the University of Bonn) is an art scholar, lecturer, critic and independent curator. Her postdoctoral research project “From National to Transnational Art: Displacement, Identity, and Belonging in Iranian Contemporary Art” explores the transformation of Iranian artists’ identities through analysis of their oeuvres and (auto)biographies. The project concentrates on four main concepts: place, estrangement, displacement and multiple belonging. In 2023, she co-organised the international workshop “Collective Traumas and Future Fantasies: The Power of (Visual) Art for Social and Political Transition in Iran” with Prof. Dr. Birgit Mersmann at the University of Bonn. From 2018 to 2021, Khorshidian worked as a critic, researcher, curator and artist manager at Tehran-based art galleries exploring experiences of estrangement and belonging surrounding Iranian identity.

**Ivana Krpan** holds a PhD in Humanities – Philology and Performing Arts (2013) and a bachelor’s degree in Spanish Philology and Comparative Literature (2005) from the University of Zagreb (Croatia). **Moritz A. Mihatsch** is a global historian interested in nationalism, self-determination and sovereignty. He is Lecturer in World History at the University of Cambridge. His research interests lie mainly within the area of Contemporary Spanish Studies. He has conducted extensive research into the literature of the 1939 Spanish Republican Exile, particularly that of the second generation in Mexico.
